- 1. The Government of Mongolia has received financing from the Asian Development Bank (ADB) toward the cost of Regional Road Development and Maintenance Project, and it intends to apply part of the proceeds of this financing to payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
- 2. The Ministry of Road and Transport ("the Purchaser") invites sealed bids from eligible Bidders for Weigh-In-Motion Digital Platforms.
- 3. Open competitive bidding International will be conducted in accordance with ADB's Single-Stage: One-Envelope procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
- 4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:

Item	Qualification Criteria
Contractual experience	Successful completion as main supplier within the last 3 years (2022, 2023, 2024), of at least one contract each valued at USD 230,000 with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply).
Technical Experience	The Bidder shall demonstrate that the goods offered have (i) been in production for at least 0.5 years, and (ii) been in operation for a minimum of 0.5 years.
Size of Operation	Minimum average annual turnover of USD 574,000 calculated as total payments received by the Bidder for contracts completed or under execution over the last 3 years.

- 5. Interested eligible Bidders may obtain further information from Ministry of Road and Transport and inspect the Bidding Document at the address given below, from 08:30 to 17:30 hours.
- 6. The Bidding Document may be purchased by interested Bidders on the submission of a written application to the address below, and upon payment of a nonrefundable fee in MNT 300,000 (Three Hundred Thousand Tugrik). The method of payment will be direct deposit to account number 100900028416 of the State Treasury for Ministry of Road and Transport. The bidding document will be picked up at the address given below.
- 7. Bids must be delivered to the address below at or before 11:00 hours, Ulaanbaatar time (GMT +8) on 28 April 2025. All Bids must be accompanied by Bid Security.
- 8. Late bids shall be rejected. Bids will be opened promptly after the deadline for bid submission in the presence of the Bidders' representatives who choose to attend. at the address below at 11:00 hours Ulaanbaatar time (GMT +8) on February
- 9. The Ministry of Road and Transport will not be responsible for any costs or expenses incurred by Bidders in connection with the preparation or delivery of Bids.
